- Prince J G von Hohenzollern, as president, chaired the meeting. He thanked Mr van Thiel warmly for his efforts in organising the conference and for his hospitality.
- The membership of the board was discussed. In addition to those board members present (and listed above), the following are also members:

Mr K Berg Mrs M Figueriedo Mr A Suslov

It was agreed that it would be advantageous to add several new members to the board and the names of Caroline Johnstone and Villard Villadsen were suggested and agreed. Since no one from the United States was any longer on the board the committee asked the president to approach one or two senior members of the profession there to join the board.

- 3 Mrs G Cavalli-Bjorkman was elected vice-president of the committee.
- The committee asked Mme Antonova to vote on their behalf at the end of the ICOM conference.
- 5 The secretary was asked to prepare a list of new members to enable the board to discuss their suitability to join ICFA as voting members. There was a danger of the group becoming too large.
- The treasurer announced that ICFA had ff 15,000 in the bank. It was felt that this money could most usefully be spent on producing a publication on a subject of interest to ICFA members.
- The committee considered two invitations to host future meetings. The first, from Marco Chiarini, was to visit Florence. The second, from Villard Villadsen was from Copenhagen. Both offers were enthusiastically supported and it was agreed that, ideally, a venue in southern Europe was preferred for 1990 with a return north in 1991. Consequently Alessandro Bettagno agreed to contact Dr Chiarini to discuss further details of the Florence meeting. The second week of October 1990 was considered the most suitable date.

The board meeting ended.

The plenary session was convened to hear a lecture given by the Director-General designate of the Rijksmuseum, Professor Dr H W Van Os. A specialist of Italian art, his subject was, appropriately, the history of the display of Italian paintings in Dutch museums. He described the collections formed in the eighteenth and early nineteenth centuries pointing out that in contrast to most other european countries they were few and insignificant. The Dutch were great collectors but they preferred their own national school.

It was ironic that Dutch Museums had benefited most from an act of foreign aggression. The Nazis seized many Dutch-owned Italian paintings during the occupation. They were taken, for the most part, from art dealers. After the war, instead of being sent back to their previous owners, the paintings were returned to several public art galleries in The Netherlands.

The plenary session ended.

- The Prince, as president and chairman, welcomed members of 1) ICFA to the plenary session. He identified the office holders of the committee and proposed that Mrs. Cavalli-Bjorkman be elected vice-president. This was seconded from the floor and agreed unanimously.
- 2) The president proposed Catherine Johnston and Villard Villadsen as new members of the board. Both agreed and were elected. He proposed to the meeting that he asked one or two senior American curators to join the board. This was also agreed unopposed. Likewise he asked Mme Antonova to vote on the committee's behalf at the end of the conference. The secretary agreed to prepare a paper of authorisation to enable Mme Antonova to vote on the committee's behalf.
- 3) The president discussed the problems that had occured since the rules governing membership had been relaxed. Applications to join ICFA had increased substantially. When the status of an applicant was unsure he or she should be asked to forward a publication from the applicant's museum. When doubt arose over an applicant's suitability to be a voting member of the committee the application would be discussed by the board at their annual meeting.
- The president relayed the two invitations from Florence and Copenhagen. Marco Chiarini would be the host in Florence and it was hoped that a meeting could be arranged for the second or third week of October 1990. Copenhagen would be the venue for 1991 when Villard Villadsen would be the host. These two invitations were warmly welcomed. It was felt that a limit of forty people was the maximum for a lively and wellorganized meeting.

- The committee proposed that there should be a theme for the 1990 meeting. The president and secretary suggested that sponsorship and the perils and pleasures associated with it was a good subject. There followed a lively discussion and several different topics were proposed. Mr. Clifford suggested historic picture hanging, Jacques Kuhnmunch, the problems connected with the single European market expected in 1992. The latter was generally accepted as both topical and worthwhile. Mr. Edouard Pommier (Inspector General des Musées de France) agreed to give a paper on the subject. Pieter van Thiel (The Netherlands) and Timothy Clifford (the United Kingdom) were invited to give papers on the position as it affected the museums and galleries in their countries.
- 6) The subject of the proposed ICFA publication was discussed. It was agreed that the publication of the papers given at the 1990 meeting on the single European market would be of great benefit to ICFA members.
- 7) The president was asked to contact Mr. Popov to ask him to talk to the membership on the present state of cultural exchanges between the Soviet Union and the rest of the world.
- 8) The president introduced Catherine Johnston, curator at the National Gallery in Ottawa, who, to an accompaniment of colour slides, spoke about the successful completion of the new building of the National Gallery of Canada. This was of particular interest to those who had heard Mrs. Johnston speak two years ago in Edinburgh when the building was still in course of construction.

The plenary session was opened by the President. He introduced Catherine Johnston who, to an accompaniment of colour slides, spoke about the successful completion of the new building of the National Gallery of Canada. This was of particular interest to those who had heard Mrs Johnston speak two years ago in Edinburgh when the building was still in course of construction.

She was followed by Prince J G von Hohenzollern who described two major acquisitions recently made by the Bayerisches National Museum, Munich. The negotiations, the purchase and the identification of two remarkable wood carvings by Hans Multscher and Veit Stoss were discussed and problems of attribution frankly admitted.

These two talks were followed by the main lecture of the afternoon. Dr Gary Schwarz spoke at length about the history of the display of seventeenth-century Dutch paintings in Dutch Museums. He described how social, political, even religious attitudes had determined the hanging of the collection of the Rijksmuseum, itself built as a temple for Dutch art with Rembrandt's Night Watch as its high altar.

There was an opportunity for questions before the plenary meeting closed.
